ROBBERY ARRESTS

January 18, 2017

On 1/17/18 at approximately 11:22 AM the Naugatuck Police were dispatched to a reported robbery at 933 Rubber Ave (Southwood Apartments). The victim, a sixteen year old male advised that he and another male friend drove to the apartments when he advised two males in ski masks approached his vehicle and advised him that he “owed them money”. The victim advised that one of the two men then started punching him in the face through his open car window and fled before the police arrived.

Officers were able to determine through the investigation that four subjects were involved in the incident. Officers learned that the four conspired to buy marijuana from the juvenile victim and devised a plan to rob the victim of the marijuana during the transaction. It was determined that the juvenile victim had made the drug transaction just before the assault occurred.

The four subjects arrested were;
