In recent months the Naugatuck Police Detective Division initiated an investigation into street-level narcotics sales in the North Main Street Area of the Borough. Through investigative efforts detectives developed information that illegal narcotics sales were occurring at 280 North Main Street Third Floor Apartment 3E, Naugatuck, CT 06770. Detectives obtained a search-and-seizure warrant for the aforementioned location.
